- The Government of the Kyrgyz Republic has received financing from the Asian Development Bank (ADB) toward the cost of School Education Reform Sector Development Program, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
- The Ministry of Education and Science of the Kyrgyz Republic ("the Purchaser") invites sealed bids from eligible Bidders for the Supply of Satellite School ICT Equipment (the "Goods").
- Open competitive bidding National advertisement will be conducted in accordance with ADB's <u>Single-Stage: Two-Envelope Bidding Procedure</u> and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - (a) Minimum average annual turnover of calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years:

USD 1,600,000.00 or KGS 139,000,000.00

(b) Successful completion as main supplier within the last 3 (three) years, of at least 1 (one) similar contract. The amount of one contract must be at least:

USD 640,000.00 or KGS 55,700,000.00

With nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).
